Throughout the remainder of the year there will be flu and vaccine clinics offered at [locations throughout Yavapai County](#). Additionally, the main [YCCHS locations](#) in Prescott, Prescott Valley, and Cottonwood are currently providing vaccines by appointment. They also offer the Moderna COVID-19 primary series and the Bivalent Booster. Not everyone has the same need for a flu vaccine, but the major benefit for most people getting it is community protection. We encourage you to go and get your flu vaccine where it's most convenient for you!

Yavapai County reports 163 COVID-19 Cases and 1 death since Wednesday, September 28<sup>th</sup>, 2022. There have been 55,281 positive cases and 1,293 deaths since the beginning of the pandemic. Yavapai Regional Medical Center reports 18 COVID patients, VVMC reports 4 patients, and the VA reports 0 patients. If you are experiencing symptoms of COVID-19 or what seems to be a bad cold, please get tested for COVID-19.
